### Warranty

The Manufacturer warrants that this product is free from defects or workmanship under normal use and service subject to the terms of this document.

### Five Year Limited Warranty

The MonsterFans Geared-Drive [GD] Series and MonsterFans Direct-Drive [DD] Series are industrial-grade construction and should provide many years of virtually maintenance-free use.

### Labor Warranty

During the first year [From the date of invoice], if there is a factory defect, Labor will be covered to remove, dismantle, reassemble, or reinstall any of the warranted products. All labor quotations must be submitted and approved by Schwank prior to work commencing. Otherwise, labor costs will be denied.

### What is not covered

The Manufacturer shall not be responsible for transportation charges incurred during the removal or reinstallation of this product, or any of its components or parts. This warranty does not cover products improperly installed, misused, exposed to, or damaged by negligence, accident, corrosive or contaminating the atmosphere, waters, excessive thermal shock, impact, abrasion, normal wear due to use, alteration, or operation contrary to the owner's manual or if the serial number has been altered, defaced, or removed. This warranty shall not apply if the electrical input to the product varies by more than  $\pm 10\%$  of the rated input on the rating plate. The Manufacturer shall not be liable for any default or delay in the performance by its warranty caused by any contingency beyond its control, including war, government restrictions, or restraints, strikes, fire, flood, acts of God, or short or reduced supply of raw materials or products.
